

Dine in 20% Cash Back Promotion

Terms and Conditions

1. The “Dine in with 20% Cash Back” promotion is valid from 1 July 2010 to 30 September 2010 (both dates are inclusive) (the “Promotion Period”).
2. The Promotion shall be tracked in the following months:
 - Month 1 = 1 July to 31 July 2010 (both dates are inclusive)
 - Month 2 = 1 August to 31 August 2010 (both dates are inclusive)
 - Month 3 = 1 September to 30 September 2010 (both dates are inclusive)
3. The Promotion is only open to all new and existing **Principal PB Credit/ Debit Cardmembers** residing in Malaysia, inclusive of employees of PB and PB’s advertising agencies.
4. PB Credit/ Debit Cardmembers who spend at participating restaurants with PB Cards will be entitled the 20% Cash Back (the “Qualified Cardmembers”). No minimum spending amount is required.

6. The 20% Cash Back is in addition to the generic Cash Mega Bonus, Reward Points and “Everyone Get Rewarded with PB Cash Back” promotion.
7. The tracking of Qualifying Retail Transactions shall be based on transaction dates.
8. The total Cash Back allocated for the entire promotion is RM45,000 and based on first come first served basis. The Cash Back payout per month is as follows:-

9. The maximum Cash Back payout is RM80 per Qualified Cardmember in a tracking month. The awarded Cash Back amount will be rounded to the nearest ringgit Cash Back amount. For example, RM10.32 = RM10 and RM10.58 = RM11.
10. The monthly Cash Back payout will be given to the fastest Qualified Cardmembers who spend with PB Cards in a tracking month and based on first come first served basis.
11. The Qualified Retail Purchases made by a Supplementary Cardmember shall be aggregated with the Qualified Principal Cardmember and the total eligible Cash Back will only be credited into the Qualified Principal Cardmember’s account.

12. The Cash Back will be credited into the Qualified Cardmember's Principal Credit/ Debit Card account within 4 - 8 weeks after the end of each tracking month and shall be reflected in the Qualified Cardmember's Credit/ Debit Card statement, itemised under "Dine in with 20% Cash Back 1/2/3".
13. The Qualified Principal Cardmember's account must be current, valid and in good standing to be eligible for the Cash Back.
14. Cash back is non-transferable to any 3rd party and non-exchangeable for up-front cash or kind.
15. In the event if the Cash Back has been credited into the Qualified Cardmember's Credit/ Debit Card account and there is a reversal of entry made on the retail transaction during the Promotion Period, the Qualified Cardmember is required to reimburse the Bank the whole amount of Cash Back awarded for the reversal entry. The Bank will charge the relevant amount into the Qualified Cardmember's Credit/ Debit Card account at any time without prior notice or assigning any reason thereof.
